## **Role and Responsibilities**

- As a member of a trained specialist review team, you'll assess imaging services against the QSI standards. You'll apply your knowledge, skills and experience flexibly, tailored as appropriate to the nature, scope and complexity of the service under review.
- You'll work within the Quality Standard for Imaging framework at all times, ensuring that our standards are applied objectively and equitably to all participating services.
- We pride ourselves on upholding our values of respect, professionalism, integrity and making a difference. As part of our QSI team, we expect you to work in a way that aligns with those values and maintain positive, professional conduct throughout the review process.
- You'll contribute to the team's final review report, ensuring that it accurately reflects outcomes agreed during the review visit, providing comments and recommendations as guided by the Quality Review Partner.

## Involvement:

The number of reviews per year decided by post holder. Reviews will either be onsite or remote averaging two-three days, plus reading time (total one week commitment per visit on average). National travel required for onsite visits.
